C. PARKING STANDS CAN ONLY BE REQUESTED LATE AFTERNOON THE DAY BEFORE ARRIVAL. PARKING STANDS SHOULD BE CONFIRMED THAT EVENING.

- D. INSECT CONTROL PROCEDURES ARE IN PLACE FOR AIRCRAFT ARRIVING AT STANSTED/EGSS. REQUIREMENTS APPLY TO ALL AIRCRAFT ORIGINATING FROM OR LANDING, WHILE ENROUTE, IN A MALARIA AFFECTED AREA. THERE ARE 3 LEVELS OF RISK: LOW, MEDIUM & HIGH. LOW IS THE ONLY RISK LEVEL ASSIGNMENT THAT QUALIFIES THE A/C / PAX FOR REMOTE CLEARANCE. CONTACT YOUR TEAM FOR DETAILS.
- B. CUSTOMS/IMM OPS HRS: BUSINESS TERMINAL-06:30-23:59 LT (O/T O/R WITH 24 HRS PN); MAIN TERMINAL-24 HOURS A DAY
- C. PAX LANDING CARDS CAN BE COMPLETED IN ADVANCE TO EXPEDITE THE CLEARANCE PROCESS. IF THIS SERVICE IS NEEDED, ALERT YOUR TEAM & ENSURE YOU PROVIDE THEM WITH INFO WELL IN ADVANCE: FULL NAMES, BIRTH DATES, PASSPORT #, ISSUE & EXPIRATION DATES, GENDER & NATIONALITY, LOCATION RESIDING DURING STAY. NOT REQUIRED FOR NON EU NATIONALS.
- A. A/C WEIGHING OVER 45.5 MT MUST UNDERGO CREW/PAX & BAGGAGE SCREENING PROCEDURES.
- B. CUS/IMM CNTRLS APPLY TO ALL A/C FROM OUTSIDE OF THE EU INTO THE UK. CREW/PAX MUST PASS THRU THE RED OR GREEN CHANNELS WHEN CLEARING CUS/IMM THRU THE COMMERCIAL SIDE. FOR A/C ARR FROM INSIDE OF THE EU. CREW/PAX MAY PASS THRU THE BLUE CHANNEL. PERSONS CAN BE OBSERVED DIRECTLY OR REMOTELY, AND CAN BE STOPPED, QUESTIONED, OR SEARCHED BASED ON CUS PROCEDURES.
- C. WHEN PROVIDING PASSPORT DETAILS YOU MUST INCLUDE:

  DATE OF ISSUE, NAME, DOB, PASSPORT #, NATIONALITY & EXPIDATE.
- D. UK REMOTE CLEARANCE FORM CAN BE COMPLETED BY US CITIZENS FOR ADVANCE SCREENING & QUICKER PROCESSING ON ARR, SUBJECT TO THESE CONDITIONS:

  APT CUS ALLOWS USE OF THE FORM, THE INFO IS ACCURATE & RECEIVED
  IN A TIMELY MANNER, AND THE APPROPRIATE RISK LEVEL IS MET PER IMM
  STANDARDS. WHEN CIRCUMSTANCES OCCUR THAT REQ A PERSON TO BE SEEN BY
  AN IMM OFCR, THEY WILL BE REQ'D TO REMAIN ON SITE UNTIL AN OFCR IS
  AVAILABLE. THE DECISION OF WHETHER AN PERSON IS PRE-CLEARED OR IS
  REQ'D TO GO TO IMM CNTRL RESTS WITH THE OFCR.
- E. EU CITIZENS, SCHENGEN COUNTRIES AND OPS FROM NORTHERN IRELAND, THE REPUBLIC OF IRELAND, AND THE ISLE OF MAN DO NOT REQ REMOTE CLEARANCE FORMS.
- F. MINORS TRAVELING WITHOUT A PARENT REQUIRE A LETTER FROM THE PARENTS STATING WHO THEY AUTHORIZE THE MINOR TO TRAVEL WITH, THE CHILD'S NAME AND PASSPORT INFORMATION. A LETTER IS ALSO REQUIRED IF TRAVELING WITH ONLY ONE PARENT IF THE PARENT NAME AND CHILD NAME DO NOT MATCH.

- A. ALL CHAPTER 2 ACFT WITH A MTOW OF 75,000 LBS (34 MT) OR MORE ARE BANNED IN EU AIRSPACE. THIS REGULATION COVERS JET ACFT ABOVE 34,000 KG MTWA OR WITH A SEATING CAPACITY GREATER THAN 19 PASSENGER SEATS. THERE IS NO AGE LIMIT REFERENCE IN THE REGULATION.
- B. PER UK ATC REGULATIONS, ACFT CREW MEMBERS ARE REQUIRED TO WEAR SAFETY VESTS WHEN ON THE RAMP.

ATC PROCEDURES EGSS/STN ↑

- A. THE UPPER LIMIT OF THE AERONAUTICAL VHF COMMUNICATIONS BAND IN ICAO EUROPE REGION HAS BEEN EXTENDED TO COVER FROM 118.0 TO 136.975 MHZ. AIRCRAFT MUST BE EQUIPPED WITH RADIOS CARABLE OF OPERATING WITHIN THE EXTENDED BAND.
- B. ALL AIRCRAFT MUST BE EQUIPPED WITH 8.33 KHZ CHANNEL SPACING & THIS MUST BE INCLUDED IN FLIGHT PLAN REMARKS.
- C. WE HAVE A COPY OF THE BASIC REQUIREMENTS FOR AIRCRAFT CLASSIFICATION & IMPORT INTO THE UK WITH FREE CIRCULATION IN THE EUROPEAN UNION. HAVE YOUR TEAM SEND YOU A COPY OF THE REQUIREMENTS IF NEEDED.
- D. BE AWARE THAT IF A PILOT HAS AN OPERATIONAL MULTI-PILOT LIMITATION (OML), THEN A PILOT OVER THE AGE OF 60 IS NOT ABLE TO FLY WITH THEM. PLEASE REFER TO COMMISSION REGULATION (EU) 1178/2011. FOR ANY ADDITIONAL AGE REGULATIONS PLEASE CONTACT YOUR TEAM FOR CURRENT INFORMATION AS POLICIES MAY CHANGE.

# A. AIRPORT SECURITY:

- THE AIRPORT MAINTAINS SECURITY 24 HRS A DAY.
- IN ADDITION TO THE AIRPORT SECURITY, PRIVATE SECURITY COMPANIES
  CAN PROVIDE THIRD PARTY HIGH GRADE STATIC GUARDS, ALONG WITH ADDITIONAL
  SERVICES WHERE AVAILABLE.
- B. RAMP AND PARKING ACCESS:
- VEHICLE ACCESS TO THE RAMP/AIRCRAFT PARKING AREAS IS AVAILABLE
- CARS CAN ENTER RAMP WITH COORDINATION WITH MIAA.
- C. PASSENGERS AND CREW SCREENING:
- THE CREW MUST HAVE A SECURITY AND/OR COMPANY I.D.
- AIRCRAFT DOCUMENTS ARE NOT USUALLY REVIEWED, BUT SHOULD BE AVAILABLE, IF REQUESTED.
- SECURITY PROCEDURES ARE IN PLACE FOR BOTH PASSENGERS AND CREW, AS WELL AS FOR BAGGAGE.
- D. 3RD PARTY VENDOR SERVICES:
- THE AIRPORT SUBJECTS 3RD PARTY VENDORS (SUCH AS CATERERS, FUELERS AND CABIN CLEANERS, ETC.) TO ACCESS SCREENING PROCEDURES.



- A. THE UK IS POLITICALLY STABLE, WITH A MODERN INFRASTRUCTURE, BUT SHARES WITH THE REST OF THE WORLD AN INCREASED THREAT OF TERRORIST INCIDENTS OF INTERNATIONAL ORIGIN, AS WELL AS THE POTENTIAL FOR ISOLATED VIOLENCE RELATED TO THE POLITICAL SITUATION IN NORTHERN IRELAND.
- B. TRAVELERS ARE ENCOURAGED TO KEEP AN EYE OUT FOR SUSPECT PACKAGES OR PEOPLE ACTING SUSPICIOUSLY ON THE SUBWAY (CALLED THE TUBE OR UNDERGROUND), AT TRAIN STATIONS, & AIRPORTS, & TO REPORT ANYTHING SUSPICIOUS TO THE APPROPRIATE AUTHORITIES. - C. BE ADVISED THAT EVEN DEMONSTRATIONS INTENDED TO BE PEACEFUL CAN TURN CONFRONTATIONAL & POSSIBLY ESCALATE INTO VIOLENCE. YOU SHOULD AVOID THE AREAS OF DEMONSTRATIONS IF POSSIBLE.YOU SHOULD STAY CURRENT WITH MEDIA COVERAGE OF LOCAL EVENTS & BE AWARE OF YOUR SURROUNDINGS AT ALL TIMES.
- D. UK AND GIBRALTAR BENEFIT FROM GENERALLY LOW CRIME RATES. OVERALL CRIME RATES HAVE DECREASED OVER THE PAST DECADE; HOWEVER, ACCORDING TO METROPOLITAN POLICE STATISTICS, SERIOUS CRIME (I.E. ASSAULT, ROBBERY, BURGLARY, GUN-ENABLED, AND RAPE) IN MANY LONDON BOROUGHS HAS INCREASED. TYPICAL CRIMINAL INCIDENTS INCLUDE PICK POCKETING, MUGGING & "SNATCH & GRAB" THEFT OF MOBILE PHONES, WATCHES & JEWELRY.
